Sir Michael Barber is one of the leading Education and Government experts of the last 20 years. In April 2021 his latest book Accomplishment: How Ambitious and Challenging Things Get Done was published by Penguin. It identifies the pattern of accomplishment across many fields including sport, business and science as well as government. It has been described by Matthew Syed as "an excellent analysis". His previous book How to Run a Government so that Citizens Benefit and Taxpayers Don't go Crazy, also published by Penguin, has been influential among politicians and officials worldwide. From 2017 to 2021 he was Chair of the Office for Students which regulates the higher education system in England. He served as Chief Adviser to the Secretary of State for Education on School Standards from 1997 to 2001 during which time school performance improved significantly. In 2001 he set up the Prime Minister's Delivery Unit in No 10 Downing Street to ensure the successful implementation of the Prime Minister's priorities in domestic policy including education and health. Having worked as Head of McKinsey's Global Education Practice and as Pearson's Chief Education Adviser, Michael now leads his own company, Delivery Associates. He is also Chancellor of the University of Exeter and an Honorary Fellow of Queen's College, Oxford. He currently advises the Chancellor of the Exchequer on the skills agenda and is Chair of the South West Social Mobility Commission. He is also Chair of Somerset County Cricket Club.

Steve Chalke MBE

Steve Chalke MBE, Founder and Leader of Oasis. Steve is a social entrepreneur, justice campaigner, author, motivational speaker, church leader and former UN Special Advisor on Human Trafficking. Steve trained in theology and in 1985 founded the Oasis Trust – which has now grown into a large group of charities – which he still leads. Oasis now has over 5,500 staff, as well as many more thousands of volunteers. Oasis pioneers housing, education, healthcare, and many other community initiatives in the UK and elsewhere around the world. Steve also serves as the senior minister of Oasis Church, Waterloo, in central London. Steve holds an MBE, a number of honorary fellowships and a doctorate from Staffordshire University, all awarded for his work in social inclusion and justice. In 2017 Steve was installed as a Canon of Southwark Cathedral. Oasis currently works in 60 local neighbourhoods around the world – 36 of which are in the UK – where it seeks to bring together the resources, expertise and infrastructure that we have developed in order to build on existing strengths and assets in the local community. Wherever Oasis works its goal is to build, and to help others build, integrated, high quality and diverse services to benefit local communities through a wide variety of activities and partnerships. It serves and respects all people regardless of their gender, race, ethnic origin, religion, age, sexual orientation or physical and mental capability and works within local communities to create neighbourhoods in which people feel known, able to thrive and can build deep and nourishing relationships. Steve lives in Central London where he also serves as the leader of Oasis work in the Waterloo community. Oasis Hub Waterloo currently serves its local community through the delivery of a children's centre, a primary school, a secondary school, various adult education opportunities, a foodbank, a debt advice centre, a church, a community farm, a coffee house, the local public library, a higher education college, a range of youth work schemes and a breadth of other programmes.





Tom Clark CBE

Tom Clark CBE was formerly Chief Executive of George Spencer Foundation School and Technology College in Nottingham during which time the school received consecutive 'outstanding' Ofsted reports. For 3 years he was Associate Director of the Specialist Schools and Academies Trust (SSAT) leading on workforceremodelling and helping to develop and network university accredited programmes for Deputy Head Teachers in Hong Kong, Australia, and The United States who were preparing for Headship. Working with the DfE he published booklets on 'benchmarking and financial planning', and 'workforce reform' and he helped create the 'Raising Achievement Transforming Learning' programme. For 6 years Tom was Chairman of FASNA (Freedom and Autonomy for Schools – National Association) and advised successive Secretaries of State on policy matters and he wrote a publication on effective financial management in schools. At the invitation of different Secretaries of State, Tom served on two 'special advisory boards' looking at the role of Local Authorities in an academised system and another on the development of a 'national fair funding' model for schools. Tom served on a number Interim Executive Boards in failing Academies. For 4 years he chaired Govnet's Advisory Education Board helping to re-shape their 'Schools and Academies (biannual) Shows'. Since December 2018 Tom has been a Board Member of ATT. He is a strong advocate of the post-Covid need to re-set aspects of the education system and he contributes to the work of international networks on this agenda.

On 6 May 2021, Steve was re-elected to serve a second term as Mayor with an increased majority of over 132,000 – winning almost 60% of the vote across the region. On day one of his new term in office, he delivered a £150m COVID recovery fund to create jobs and support businesses as the region emerges from the pandemic and has since secured almost threequarters of a billion pounds from central government for transport in the region.

He became particularly well known for Mossbourne Academy in Hackney, East London, where he transformed one of the worst schools in Britain into one of the best, sending large numbers of children to top universities including Oxford and Cambridge. Between 2007 and 2012, whilst still principal of Mossbourne Academy, Sir Michael was appointed as the part-time Director of Education at ARK Schools, one of the largest and most successful Multi-Academy Trusts in England. In this role, Sir Michael was responsible for standards in all of the constituent academies within the Trust. Sir Michael has held a number of senior advisory positions to the UK Government and also to education ministries abroad including those of Brazil, Nepal, New Zealand and Australia. He has been a Trustee of the Prince of Wales' Teaching Institute and a member of the National Advisory Group for the Children's Plan and for London Challenge. Sir Michael is an Honorary Doctor at the Universities of Greenwich and East London, a fellow of Birkbeck College, London University and a Freeman of the City of London. He has recently been appointed as Professor of Education at St Mary's University in London. In 2000, he was knighted by the Queen for Services to Education.
